DECLARATION OF AN AREA AS A CONSERVANCY: !KHOB !NAUB (KALK PLATEAU) CONSERVANCY

In terms of section 24A(2)(ii) of the Nature Conservation Ordinance, 1975 (Ordinance No. 4 of 1975), I declare the area, of which the geographic boundaries are set out in the Schedule, as the !Khub !Naub (Kalk Plateau) Conservancy situated in the Karas Region.

**DESCRIPTION OF BOUNDARY OF THE //HUAB CONSERVANCY
SITUATED IN THE KUNENE REGION**

The point of beginning is the most eastern corner of farm **Halt 379** at point **A**.

From the point of beginning the boundary follows the south-eastern boundary of **Halt 379** in a south-western direction; and then moves in a generally western direction along the southern boundaries, in turn, of farms **Halt 379**, **Horison 489**, **Tussenby 729**, **Bergville 490**, **Lofdal 491**, **Ruimte 510**, **Rushof 509**, and **Toekoms 508** to point **B** at the most southern corner of **Toekoms 508**. From point **B** the boundary continues in a generally north-western direction along the western boundaries, in turn, of farms **Toekoms 508**, **Boesmanspan 507**, **Soutput 505** and **Noute 674** to point **C** at the north-western corner of **Noute 674**. From point **C** the boundary proceeds in a generally eastern and then north-eastern direction along the northern boundaries, in turn, of farms **Noute 674**, **Eersbegin 675**, **Tweelingskops 676**, and **Anabis 677** to point **D** at the north-eastern corner of **Anabis 677**. From point **D** the boundary carries on firstly in a southern direction along the eastern borders of farms **Anabis 677** and **Spitskop 678** to the intersection with the north-western corner of farm **Aub 683**, and then in an eastern direction along the northern borders of farms **Aub 683** and **Smalruggens 684** to point **E** at the north-eastern corner of **Smalruggens 684**. From point **E** the boundary progresses in a south-eastern and then south-western direction along, firstly, the eastern boundary of **Smalruggens 684** and then the southern boundaries of farms **Smalruggens 684** and **Rockeyes 682** to point **F** where it meets the north-eastern corner of farm **Braklaagte 492**. From point **F** the boundary advances in a south-eastern direction along the eastern boundary of **Braklaagte 492**, continues along the north-eastern boundary of farm **Potgietersrust 489**, turns easterly and then continues along the northern boundary of **Horison 489** to its intersection with the most northern corner of **Halt 379**, and then returns in a south-eastern direction along the north-eastern boundary of **Halt 379** back to the point of beginning.

**DESCRIPTION OF BOUNDARY OF THE //GAMASEB CONSERVANCY
SITUATED IN THE KARAS REGION**

The point of beginning is situated in the south-western corner of the farm Grootplaas Wes 260. From the point of beginning the boundary follows the southern boundaries of the farms Grootplaas Wes 260, Grootplaas 15, Uitschot 149 and Plankieskop 95 in a north-eastern direction to the most western boundary of the farm Obub 47. From there the boundary moves in a south-eastern direction along the south-western boundary of the farm Obub 47 and then in a southern direction along the western boundary of Kalkfontein West 48 and Naruchas 48 up to the south-western corner of Naruchas 48. From this point the boundary follows the northern boundaries of the farms Swarthuk 121, Dabegabis 122, Luginsland 124, Nieuwefontein West 144, Pollux 143 to a point mid-way along the northern boundary of the farm Riverside 256. The boundary then follows a northern direction along the eastern boundaries of the farms Horhoon, Ysterputs 254 and Louwshoop 330 to the point of beginning.
