OSKOP CONSERVANCY, HARDAP REGION**

SCHEDULE**BOUNDARY DESCRIPTION OF THE OSKOP CONSERVANCY**

From the north-western corner of the farm Oskop 69, (being the point of beginning) generally eastwards along the northern boundary of the farm Oskop 69 to the point of intersection with the north-eastern corner of the said farm; thence generally southwards along the eastern boundary of that farm to a point of intersection with the north-eastern corner of the farm Ventershoop 164; thence generally westwards along the northern boundary of the farm Ventershoop 164 to a point of intersection with the south-western corner of the farm Oskop 69; thence generally northwards along the western boundary of the last-mentioned farm to the point of beginning.
