DESCRIPTION OF BOUNDARY OF THE SANITATAS CONSERVANCY SITUATED IN THE KUNENE REGION

The point of beginning is at the intersection of the eastern boundary of the Skeleton Coast Park. From this point the boundary moves in an eastern direction to point 2, then in a northeastern direction to point 3. From this point it follows a northern direction up to point 8 and then proceeds in a north-eastern direction up to point 13. From here it moves in a northern direction up to point 15 and then turns eastwards through point 16 to point 17. From this point it moves southwards up to point 18 from where it turns in a south-eastern direction to point 19. From this point the line moves in a south-western direction through point 20, 21, 22, 23, 24, 25, 26, 27 up to point 28 which is situated on the eastern boundary of the Skeleton Coast Park. From this last point the line moves in a north-western direction following the Skeleton Coast Park boundary up to the point of beginning.

DESCRIPTION OF BOUNDARY OF THE ORUPEMBE CONSERVANCY SITUATED IN THE KUNENE REGION

The point of beginning is at the intersection of the eastern boundary of the Skeleton Coast Park. From this point the boundary moves in an eastern direction to point 2, then in a northeastern direction to point 3. From this point it follows a northern direction up to point 8 and then proceeds in a north-eastern direction up to point 13. From there it moves in a northern direction up to point 15, from where it moves in a north-western direction up to point 16. From this point it moves in a south-western direction up to point 17 and from there in a western direction up to point 18. From this point it moves in a southern direction, following the eastern boundary of the Skeleton Coast Park to the beginning point.
